#### <u>DEBT</u>

Our national debt has increased by \$5.1 TRILLION Dollars.

"If you started spending the day Jesus was born and you spent a million dollars every single day, you still wouldn't have spent a trillion dollars by 2009." (Sen. Mitch McConnell)

If we immediately stop spending and begin paying off the debt at the rate of \$1.00 per second, it would take 497,840 years to pay it off.

Our national debt is larger than the total economies of China, the U.K. and Australia combined. (Defeatthedebt.com)

Our national debt now exceeds 100% of our GDP - the total value of all goods and services of the U.S.

Congress is required to pass a budget by April 15. Under Obama, Senate Democrats have <u>not</u> passed a budget in over three years.

Some stimulus "green energy" highlights: (AFP)

- \$1.2 billion went to a solar energy company to help finance a new plant **in Mexico.**
- \$500 million to an electric car company which created hundreds of jobs **in Finland**.
- Tens of millions of dollars to build traffic lights in China.

## U.S. MILITARY

## **FOREIGN AFFAIRS**

In May 2011, President Obama called for Israel to return to its 1967 boundaries. *(abcnews.go.com).* It would result in a divided Jerusalem, its capital city. Israeli Prime Minister Netanyahu rejected the proposal saying it would make Israel "indefensible." *(Telegraph.co.uk)* 

President Obama, thinking his microphone was off, asked Russia's President Medvedev for "Space" on missile defense, saying, "After my election, I'll have more flexibility." Medvedev responded, "I will transmit this information to Vladimir." (*ABC News* – 3/26/12)

## **IMMIGRATION**

## **GUN CONTROL**

The 2<sup>nd</sup> Amendment to the U.S. Constitution reads: "...the right of the people to keep and bear Arms shall not be infringed."

The House voted on 6/28 to hold Attorney General Eric Holder in contempt for refusing to turn over documents tied to the <u>Fast and Furious gun-running sting</u>. This marks the first time in American history that an attorney general has been held in criminal and civil contempt. *(CNN)* 

The DOJ dismissed charges against the New Black Panther Party for voter intimidation in Philadelphia's 2008 elections. *(foxnews.com, 6/30/2010)* 

Obama Administration sends military into Libya without notifying Congress, in violation of the War Powers Act. Leon Panetta, Secretary of Defense, tells Congressional Committee/Jeff Sessions that the Administration would seek <u>international</u> permission and THEN come to Congress and inform them. (*Freedom21, 4/7/2012*)

## **TREATIES**

The Obama Administration supports several treaties that... if ratified. threaten our national sovereignty. Once ratified, these treaties become law and supersede our Constitution.

**Law of the Sea Treaty (LOST) –** already signed and needs to be ratified. 1/2 of oil & gas revenues from wells beyond 200 miles off shore would be paid to the International Seabed Authority to be redistributed to other countries. Technologies would also be shared without compensation.

**UN Non-Aggression Treaty:** No nation may attack another nation without UN approval. Should a nation launch an attack without UN approval, its government and military leaders would be liable to be brought to trial at The World Court or The International Criminal Court if that treaty is ratified.
